

## TIMELINE

<u>DATE</u>	<u>EVENT</u>
Early 2007	Allison and Mark meet.
April 2007	Mark creates Xynga.
September 2007	Allison and Mark get engaged.
Early 2008	The parties move to Denton County, Texas.
Early 2008 (before marriage)	Mark tells Allison about his Ranchton idea. Mark meets with Facebook to become Facebook's exclusive provider of social media platform games.
July 2008	Mark and Allison discuss premarital agreement and hire attorneys.
September 2008	Mark delivers initial schedule of his assets and liabilities to Allison and her premarital agreement attorney.
November 12, 2008	Allison send an e-mail to Mark wanting to finish the premarital agreement and get it signed...because then it's on to the fun stuff.
November 14, 2008	The parties sign a waiver of disclosure and a premarital agreement before a notary public.
December 27, 2008	Mark and Allison marry.
January 16, 2009	The parties sign a ratification/marital property agreement.
January – March 2009	Allison gives Mark her ideas about Ranchton. Mark incorporates Xynga, with Mark owning all shares. Xynga, Inc. and Facebook sign a contract. At the same time, Mark sells Ranchton to Xynga for one million shares of Xynga stock, while remaining sole shareholder.
June 2009	Allison launches Two Queens Road with Sue Fieldman.
2011	Xynga, Inc. goes public, with Mark retaining a 30% stake.
2011	Parties buy house in Marin County.
2012	Parties sell Marin County house and buy a four-bedroom condo in San Francisco.
March 1, 2013	Todd and Thomas are born.

2016	Allison sells Two Queens Road for \$30 million.
2016	Allison begins use of prescription drugs for pain management.
March 2017	Allison enters 60-day drug rehabilitation program, but leaves after 30 days.
Later in 2017	Mark finds Allison's IOP records, which angers Allison.
February 2018	Allison becomes pregnant with Lucy.
June 2018	Mark stays in San Francisco.
Summer 2018	Twins fly between parents, escorted by Nancy Poe.
Mid-August 2018	Twins start kindergarten in San Francisco.
November 5, 2018	Lucy is born.
December 3, 2018	Allison files for divorce in Denton County. Her petition includes a request for disclosure due in 50 days.
December 10, 2018	Mark files his answer, which includes a request for disclosure due in 30 days.
December 14, 2018	Agreed temporary orders are entered, with support payments due on the first and fifteenth days of each month beginning in January 2019 and interim attorney's fees due half on December 20, 2018 and half on February 1, 2019.
December 15, 2019	Allison tells her life coach the children suck the life out of her.
January 7 – 9, 2019	Mark downloads Allison's electronic information without her knowledge.
January 9, 2019	Allison serves her response to request for disclosure and her Petition to Annul Marriage and, in the Alternative, First Amended Petition for Divorce. Allison gets a new iPhone and new iCloud account.
January 15, 2019	Mark files Petition for Divorce in California.
January 16, 2019	Mark files counter-petition and refuses to make further payments for interim attorney's fees and temporary spousal support.

January 21, 2019	Mark provides Allison's IOP records and life coach sessions to his lawyers.
January 24, 2019	Parties have their depositions taken.
January 28, 2019	Mark files his motion for partial summary judgment
February 1, 2019	Mark files a motion to compel Allison to produce her mental health records.
February 3, 2019	Allison files a motion for protection.
February 11, 2019	Denton court orders in camera inspection of mental health records and appoints a custody evaluator.
February 12, 2019	Mark's lawyer sends letter to custody evaluator with a copy of her drug rehabilitation records.
February 13, 2019	Mark files a motion to modify temporary orders. Allison files motion for confidentiality order. Hearing set for February 18, 2019.
February 14, 2019	Allison files her response to the motion for partial summary judgment
February 18, 2019	Parties appear for hearing on motion to modify temporary orders and motion for confidentiality order. Court declines to hear temporary orders but enters confidentiality order.
February 19, 2019	Allison files a motion for sanctions. Court sets hearing on same for February 23, 2019.
